



## How Do You Tarp? Calendar Photo Contest 2023

Safely photograph your vehicle with a Roll-Rite® or Pulltarps® tarp system either partially operated or covering your vehicle using the following guidelines and in accordance with all of the rules set forth in this document (these “Rules”) and submit **by midnight Friday, December 1, 2023.**

**Introduction/Eligibility:** Roll-Rite, LLC (“Sponsor”) is offering this Calendar Photo Contest 2023 (the “Contest”). - Please submit content in the highest quality setting your camera allows (high quality JPEG, HD mp4, etc) Images smaller than 600 by 800 pixels are not suitable for print publishing and may only be featured online

- 50% weight given to photo *composition & focus* with complete vehicle in frame with the tarp system with tarp extended, either partially deployed over vehicle or fully deployed over vehicle or load.
- 30% weight given to photo *background composition* (with no identifiable vehicles, persons, or excess clutter)
- 20% weight given to overall impact with consideration to *lighting, color and contrast*.

The contest will take place under the supervision of the Sponsor. Entrants agree to be bound by these rules and the decision of the judges, whose decisions are final. Potential winners will be notified by e-mail or mail by January 31, 2024.
